ICB update

Positive local healthcare updates were shared, with the recognition that further improvements are still required:

- The number of patients accessing pharmacy services for support with low level illnesses has
 increased. In June, referrals were up by 70% and 2525 patients used the service. This is very
 positive as it means that those patients were not being seen unnecessarily by a GP or A&E.
- Ambulance handover rates have also greatly improved.
- Following the Covid-19 pandemic, the number of people added to elective care waiting lists greatly
 increased. However, work has been underway to resolve this and 600 people who had been waiting
 the longest have now been treated. The aim is now to clear the 65-week waiting list by February
 2024.
- As a result of work that has been underway locally, life expectancy rates for people with learning disabilities have increased from 59 to 61 years of age.

Question: What is the average time for ambulance hand over at A&E?

Answer: Over the past three months: July 2023: 20 minutes, August 2023: 24 minutes ad September 2023: 26 minutes. This information has been sourced via East Midlands Ambulance Service (EMAS) commissioning portal.

NHS LLR ICB 5-year joint plan

Comments: It is positive to see joined-up working between social prescribing and the NHS. Social prescribers and local area coordinators provide great support GP surgeries. The 5 year plan is an impressive and important piece of work.

Question: Will representatives from social care be invited to future PPG Network meetings to discuss how they are working more effectively with the NHS and what effect that will have on patients?

Answer: This will be considered as a future agenda item and conversations about how best to structure the session are underway, considering there are three local authorities in Leicester, Leicestershire and Rutland, each with their own social care team.

Question: What is the role of district, borough, and town council messages.

Answer: The national guidance encouraged upper tier involvement, so we involved the three Health and Wellbeing Boards in Leicester, Leicestershire, and Rutland. Although not required in the guidance, at a county level, we held a meeting with district and borough councils to ensure they were cited and in agreement on the plan. We continue to involve them in conversations about the plan. Integrated care systems are working toward subsidiarity, which means making decisions at the most local level, such as by neighbourhood, reflecting local needs. A future agenda item for the PPG Network meeting will be neighbourhood/community wellbeing plans, which are developed in collaboration with local authorities.

Question: Which departments in the borough councils are taking this on?

Answer: Discussions have taken place with senior members of the councils and information will be cascaded to relevant departments. There is a meeting of communications and engagement leads from the local NHS and local authorities, during which we can ensure that the right departments are being involved in the plan.

Primary care and enhancing patient engagement

Comments:

- Encouraged that so much good work with PCNs is underway.
- It would be useful to have a closer relationship with PCN managers and to understand what is happening in other PCNs.
- It is positive to see GPs working with community centres.
- Other than traditional meetings, PPGs may need to consider different ways of working to reach more people.
- It is important to combine digital communications, such as email and text, with non-digital methods to reach a wider audience.
- The GP text messaging system works well, even for elderly patients.

Question: How can PPGs share resources and information with one another?

Answer: Via the PPG network knowledge hub, as well as another PPG Network Meeting focussed on sharing best practice, similar to the March 2023 meeting.

Question: Is it in the practice manager job description to support the surgery's PPG?

Answer: Each practice is responsible for their own recruitment and job descriptions. However, the national GP contract states that GP surgeries should have a PPG. It is also expected that the latest Care Quality Commission (CQC) standards and guidance will have more of an emphasis on patient engagement.

Question: With regard to patients getting involved in opportunities outside of the GP surgery, University Hospitals of Leicester NHS Trust (UHL) invite patients to join research groups, as they recognise the value of patient involvement. Can we find out if there are more opportunities and ask if patients want to be involved?
